



GENERAL TERMS & CONDITIONS OF A SAFARI WITH LINDSAY FRASER HUNTING SAFARIS NZ LTD trading as Fraser Safaris New Zealand – Woodbury Safari Lodge (LFHSNZ)

1. All prices quoted or published are in **United States currency (USD)** unless noted.
 2. A 25% deposit of the total calculated hunt cost is due on booking the dates of the hunt. A further 25% is due by the 15th of January of the year the hunt is to be taken. *Prices do not include 7.5% NZ Govt GST tax.*
 3. The balance of the total hunt cost is paid at the conclusion of the hunt.
 4. Payment for deposits & balances can be any combination of the following: wire transfer, credit card and cash.
 5. The following credit cards are accepted: Visa & MasterCard (subject to 3% processing charge). *We do not accept American Express*
 6. The hunt contract specifies the species of animals booked, daily rates & trophy fees or package combo hunt details & any additional daily hunts booked such as wing shooting & fishing.
 7. All species booked & deposited are not subject to any price increases --- otherwise most recent web published price list to be used.
 8. Not included (unless otherwise noted on the hunt contract) are the following: Personal liquor, tourist accommodation & food, admissions for non-hunters in your party when touring away from lodge, meals while traveling on arrival & departure days & tips for guide and lodge staff.
- Field skinning of your trophies is included in the hunt - not included is taxidermy preparation, salting, boiling, export crating, export documentation, NZGAC export levies (if required) & shipping of the export trophy crate from New Zealand to the final destination.
9. Wounded & lost trophies are charged at 100% of the applicable trophy fee
 10. **Handguns & military type semi---autos are illegal for hunting in New Zealand and should not be carried into the country.**
 11. The hunter named in the attached hunt contract is responsible for all travel arrangements to & from Christchurch Airport or another nominated New Zealand airport, as noted on the Hunt Booking Contract, for all members of the group/party.
 12. The hunter shall be responsible for obtaining all the necessary travel, medical, liability & trip cancellation insurance as he/she deems appropriate for all members of the group/party.
 13. The hunter shall be responsible for notifying LFHSNZ of any existing medical conditions, physical limitations or medicine use that needs to be allowed for during the period of the safari or emergency admission to hospital in New Zealand. I/we agree to fill out the standard Medical Form prior to starting our hunt.
 14. LFHSNZ will make every effort to adhere to the hunting schedule previously arranged for during the hunt period, but reserves the right to alter the daily schedule due to (but not limited to) changing weather conditions,



better game availability on another area or due to illness or non-availability of the originally nominated LFHSNZ professional contract hunting guide.

15. LFHSNZ and its staff, agents or contractors will make all reasonable efforts to assist the hunter in the hunting & shooting of all the game booked for and of the quality desired. But due to the nature of New Zealand's climate & current game availability, an absolute guarantee of success cannot be given.

16. All digital images (photos & video) taken on LFHSNZ equipment (including contract guide's cameras) remains the sole copyrighted property of LFHSNZ. Photos will be made available for clients for personal use.

17. Meat from harvested trophies remains the sole property of LFHSNZ. We do not offer meat processing for export.

18. Deposits are non-refundable in the event of cancellation. However with LFHSNZ's agreement, the deposit value may be transferred to another person as long as the new hunt is of similar value and the same original booked hunt date.

19. It is agreed by the hunter and members of his/her group/party comprising the safari, that hunting, fishing and the use of transportation such as 4 wheel drive vehicles, ATVs, planes & helicopters that may be used during the safari, involves a level of potential danger and could result in death or personal injury. LFHSNZ Ltd will take all reasonable precautions to ensure safety but it is agreed by the hunter (including the hunter's heirs, executors, administrators or assignees) that all activities while on safari are at the hunter's & safari group/party members risk and hereby irrevocably waives and abandons all and whatsoever rights that they may have against LFHSNZ Ltd, its directors, shareholders, employees, agents or contractors arising out of the consequence of any death, damage injury, illness, or from any other cause as a result of undertaking this safari.

20. I agree to abide by the LFHSNZ/Woodbury Lodge Health & Safety Manual & Lodge Firearms Safety Codes and will follow any reasonable instruction given to me by my hunting guide.

I/we have acquainted myself to the above terms & conditions, which I understand and accept. I warrant that I am able to sign this contract on behalf of the other people (if any) listed on the Hunt Booking Contract.

Lodge Firearms Safety Code

Hunters must follow every part of the New Zealand Firearms Safety Arms Code, and should know and comply with its seven basic rules at all times:

1. Treat every firearm as loaded.
2. Always point firearms in a safe direction (place unloaded firearm muzzle down in vehicles).
3. Load a bullet into the chamber of your firearm only when instructed by your guide and ready to fire.
4. Identify your target beyond all doubt. If in doubt consult your guide.
5. Check your firing zone.
6. Store firearms and ammunition safely (your guide will assist you with this – no guns in Lodge bedrooms).
7. No alcohol when handling firearms or during hunting.
8. Any guide for Fraser Safaris NZ (LFHSNZ) can stop the hunt in progress, based on any unsafe activity with a firearm by the hunter being guided.

WAIVER | RELEASE | LIABILITY DISCHARGE FOR HUNT

Lindsay Fraser Hunting Safaris NZ Ltd & Woodbury Lodge Ltd

1. It is agreed by the Hunter and members of his/her Group (including other Hunters & Lodge Guests) comprising the Hunt, that hunting, fishing and the use of transportation such as 4 wheel drive vehicles, UTV's, planes & helicopters that may be used during the Hunt, involves a level of potential danger and could result in death or personal injury.

2. Other potential risks include (but are not limited to) uneven terrain, changing weather conditions, use of firearms/bows, the Hunt Group Members physical fitness levels, time needed to medevac in the case of an accident & other risks associated with a physical activity undertaken in the outdoors.

3. It is agreed by the Hunter (including the Hunter's heirs, executors, administrators or assignees) that all activities while on the Hunt are at the Hunter's & Hunt Group Members risk and hereby irrevocably waives and abandons all and whatsoever rights that they may have against Lindsay Fraser Hunting Safaris NZ Ltd or Woodbury Lodge Ltd, it's directors, shareholders, employees, agents or contractors arising out of the consequence of any death, damage injury, illness, or from any other cause as a result of undertaking this Hunt.

4. I HEREBY WAIVE, RELEASE AND DISCHARGE from any and all liability for death, disability, personal injury, property damage, and all other foreseeable risks, claims or actions of any kind (including negligence) whatever and however occurring which may arise, at any time, from or in connection with, directly or indirectly, my participation in the Hunt the following persons or entities: LJ Fraser, Fraser Safaris NZ, Lindsay Fraser Hunting Safaris NZ Ltd, Woodbury Lodge Limited, it's directors, shareholders, employees, independent contractors, representatives, agents and volunteers.

5. I HEREBY INDEMNIFY AND HOLD HARMLESS the persons or entities mentioned in clauses 3 & 4 above, from any and all liabilities, claims or actions (including negligence) whatever and however caused which may arise, at any time, as a result of or in connection with, directly or indirectly, our participation in the Hunt and vis-à-vis any third party, as far as this third party suffered any damage or injury during the Hunt due to our participation in the Hunt.

6. I/We consent to receive any medical treatment that may be deemed necessary in the event of injury, accident or illness during the Hunt,

7. I have read and voluntarily sign this Waiver, Release and Liability Discharge Form and explicitly agree to its content and I am able to sign on my behalf and the other Hunt Group Members of this Hunt.
